The 2017 Clark Fork Market season is May 6th - October 28th. The market operates Saturdays, with hours of 8:00am-1:00pm through September, and 9:00am-1:00pm for the month of October. We are located at 225 South Pattee Street in the Riverside Parking Lot, Missoula, MT.

Vendors are not allowed to sell until their application and any relevant licenses or certificates have been received and accepted by the Market Manager and/or the Board of Directors. Incomplete applications will not be accepted. Please follow these steps to ensure that your application is properly processed.

1. Please read the Market Regulations carefully (can be found at clarkforkmarket.com or hard copies can be requested from the Market Manager).
2. Please complete each section of the application.
3. Be sure to check appropriate product categories and add any relevant information.
4. Indicate how many spaces you require, as well as any specific space requirements/requests.
5. Sign the application.
6. Enclose any required affidavits, copies of licenses (county or state). If space reservation has been confirmed, also submit payment. Please make checks payable to Clark Fork Market. ****Reserved vendors must send in their applications by April 29th, 2017 in order to secure their space (unless other arrangements have been made with the Market Manager).**
