Vendors are not allowed to sell until their application and any relevant licenses or certificates have been received and accepted by the Market Manager and/or the Board of Directors. Incomplete applications will not be accepted. Please follow these steps to ensure that your application is properly processed.

1. Please read the Market Regulations carefully (can be found at [clarkforkmarket.com](http://clarkforkmarket.com) or hard copies can be requested from the Market Manager).
2. Please complete each section of the application.
3. Be sure to check appropriate product categories and add any relevant information.
4. Indicate how many spaces you require, as well as any specific space requirements/requests.
5. Sign the application.
